Introduction

As part of ongoing efforts to support military personnel in managing and understanding post-traumatic stress disorder (PTSD), an information booklet dedicated to this sensitive topic has been created. Given the significant impact of PTSD on military members, it is essential that the information materials distributed are both accessible and relevant to their specific needs.

In order to evaluate the effectiveness of the brochure and ensure that it adequately meets the needs of the military, a pilot session was organized with the participation of active military , veterans, servicemen with disabilities from various branches of the military. During this meeting, the servicemen had the opportunity to answer a series of questions aimed at collecting opinions and suggestions about the content and presentation of the brochure.

This impact report summarises the feedback received and provides a detailed analysis of the responses, highlighting both the positive aspects and those that need improvement. The ultimate goal is to adapt and refine the brochure to maximize its usefulness for military personnel, thus contributing to a better understanding and management of Post-Traumatic Stress Disorder.

Collected results

Chapter 1 - Emotions and Localization in the Human Brain. The influence of emotions on behavior

❖ Design Section

Q1. What do you think of the design of chapter 1?

Interpret Q1:

The feedback collected on the design of Chapter 1 of the brochure largely reflects a positive response from the military. Most of the responses are favorable, indicating that the design is considered attractive and well-made. Terms such as "very cool," "cute," "interesting," "attractive," and "enjoyable" are frequently used, suggesting that the visual aspect of the material is appreciated and resonates well with the target audience.

Several responses emphasize that the design is not only aesthetic, but also "suggestive" and "engaging", indicating that it manages to capture attention and effectively convey information about emotions and their influence on behavior.

Only one response suggests that the design "could be revised", which indicates a possibility for improvement, but it doesn't seem to be a major problem, given the overwhelming number of positive comments.

Recommendations:

- Maintaining design elements that have been appreciated, ensuring that the material remains visually attractive and engaging.
- Exploring small suggested adjustments or revisions, without substantially altering the design, to also respond to minority opinions.



Interpreting Q2

The results of the survey on the evaluation of the design of chapter 1 are extremely favorable. An overwhelming percentage, 96% of respondents, consider the design to be pleasant and attractive. This positive feedback confirms that the visual elements of the brochure manage to attract and please the majority of readers.

None of the respondents chose the "No" option, which indicates that the design does not present significant problems that require immediate attention. However, 4% of respondents suggested that the design could be improved, indicating a small opportunity for adjustments that would further improve the visual appearance.

Recommendations:

- Continue to use current design elements, given the extremely positive feedback.
- Specific investigation of the comments of the 4% of respondents who indicated that the design could be improved, to identify possible adjustments that could bring additional benefits.



Interpreting Q3

The survey results show that chapter 1 design has a very positive impact on the desire to go through the content. 92% of respondents said that the design is inspiring

enough to motivate them to read the material. This high percentage suggests that the design not only attracts attention but also stimulates interest in deepening the information presented.

No respondent indicated that the design is not inspiring enough, which denotes that there are no major problems in terms of the visual appeal of the material. However, 8% of respondents felt that the design could be improved, providing an opportunity to refine certain aspects to further enhance the attractiveness and effectiveness of the brochure.

Recommendations

- Maintaining the design elements that have obtained majority positive feedback.
- Analyzing the comments of the 8% of respondents who suggested improvements to identify specific changes that could be implemented to increase inspiration and attractiveness.



Interpret Q1:

Analysis of the responses to the content of Chapter 1 shows that the majority of servicemen consider the material to be of superior quality. 64% of respondents rated the content as "excellent," suggesting that the information presented is relevant, well-structured, and valuable to readers. 28% of respondents described the content as "good", indicating that although the material is appreciated, there is room for improvement to achieve an even higher level of excellence. 8% of respondents indicated that the material "needs improvement", highlighting that there are certain aspects that could be revised or developed to increase the effectiveness of the information provided.

Recommendations:

- Retaining content that has received excellent ratings, to maintain the high quality of the material.
- Identify and analyze aspects that can be optimized based on the feedback of respondents in the "good" and "needs improvement" categories, in order to further improve the relevance and impact of the information presented.



Interpret Q2:

The responses received regarding the ease of reading the content of chapter 1 are mostly positive. 88% of respondents indicated that the material is "very easy" to navigate, which shows that the brochure is well organized and easy to understand. This is essential to ensure good accessibility of the information presented. 12% of respondents felt that the material was "partly easy" to navigate, suggesting that there are certain sections that could be improved to make the information even easier to understand and use. None of the respondents chose the "difficult" option, which confirms that, overall, the chapter is well structured and accessible to readers.

Recommendations:

- Continue to use the current structure and style of presentation of information, given the very positive feedback.
- Review the sections identified as partially easy to navigate in order to identify and implement possible improvements to ensure a reading experience as fluent and accessible as possible for all readers.



Interpret Q3:

The feedback on the clarity of the terms and wording in Chapter 1 is extremely positive. 88% of respondents consider the terms and expression to be "very easy to understand", which indicates that the language used in the brochure is accessible and well adapted to the target audience. This is crucial for ensuring a good understanding of information about post-traumatic stress. 12% of respondents rated the language as "partly easy to understand", suggesting that there are certain aspects of the text that could be clarified or simplified to improve overall comprehensibility. None of the respondents found the terms and wording difficult to understand, confirming that the brochure is, overall, effective in terms of communicating information.

Recommendations:

- Continue to use the current terms and style of expression, given the majority positive feedback.
- Review sections identified as partially understandable to identify and implement possible improvements to increase the clarity and accessibility of the text.



Interpret Q1:

The answers regarding the usefulness of chapter 1 for understanding post-traumatic stress syndrome are unanimous and extremely positive. All respondents (100%) answered affirmatively, considering this chapter to be useful for understanding PTSD. This feedback indicates that the material presented is perceived as highly relevant and beneficial to readers, managing to provide clear and valuable information about PTSD. The fact that no respondent chose the "No" or "Don't know" variants underscores the effectiveness and clarity of the content, demonstrating that this chapter successfully fulfills the objective of educating and informing readers about post-traumatic stress disorder.

Recommendations:

- Maintaining the current structure and content of the chapter, given the unanimously positive feedback.
- Continue to apply the same informative and clear approach in the other chapters of the brochure to ensure a consistent level of usefulness and relevance.



Interpret Q2:

The majority of respondents (92%) believe that going through this chapter will help both active and reserve military personnel. This positive feedback suggests that the information presented is perceived as valuable and relevant to the military's needs in terms of understanding and managing post-traumatic stress disorder. None of the respondents chose the "No" option, which shows that there are no significant negative perceptions related to the usefulness of the chapter. However, 8% of respondents chose the "I don't know" option, which indicates a little uncertainty about the impact of the chapter. This may reflect either a lack of familiarity with the content or a perception that the material could benefit from further clarification.

Recommendations

- Continue to use current content, given the majority positive feedback.
- Addressing the uncertainty expressed by 8% of respondents through additional clarifications or concrete examples illustrating how the chapter can help active and reserve military personnel.

Chapter 2 - Exacerbated fear - the precursor emotion for the onset of post-traumatic stress

Interpret Q1:

The feedback on the design of Chapter 2 reflects a general appreciation from respondents. Terms such as "great", "very cool", and "interesting" indicate that the design is well received and considered pleasant. Aspects such as "very suggestive and engaging" and "visually pleasing design" suggest that visual elements are effective in capturing and maintaining readers' attention. Most respondents noted the design as attractive and well-made. However, there is also a suggestion for a possible revision, indicating that there are opportunities for improvement.

Recommendations:

- Continuing to use appreciated design elements, maintaining visual standards that have been well received.
- Consider revision suggestions to make minor adjustments that could further enhance the attractiveness of the design.



Interpreting Q2

No respondent found the design unattractive or in need of improvement, which emphasizes that the design elements are well done and well received by the target audience.

Recommendations:

- Continue to apply the same visual approach in the other chapters of the booklet to ensure consistency and attractiveness of the material.



Interpreting Q3

Feedback shows that the design of Chapter 2 is extremely inspiring for most respondents. 96% of participants said that design can inspire them to scroll through the content, indicating that visual elements manage to attract and maintain readers' interest. None of the respondents found the design uninspiring, demonstrating that there are no significant problems in this regard. However, 4% of respondents suggested that the design could be improved, which provides an opportunity to refine some elements to further enhance the appeal and ability to inspire readers.

Recommendations

- Maintaining design features that have garnered majority positive feedback.
- Evaluating suggestions for improvement to identify specific adjustments that could be implemented to further increase the degree of inspiration provided by the design.



Interpret Q1:

The evaluation of the content of chapter 2 indicates a very good overall assessment from the respondents. 80% of participants described the content as "excellent", suggesting that the material presented is well-structured, informative and relevant to readers. This mostly positive feedback indicates that the chapter manages to effectively convey information about exacerbated fear and its link to post-traumatic stress. 16% of respondents considered the content "good", which shows that although the material is appreciated, there is room for minor improvements that could turn the appreciation from "good" to "excellent". 4% of respondents mentioned that the content "needs improvement," suggesting that there are some specific aspects that could be developed or clarified to improve the overall quality of the chapter.

Recommendations:

- Maintaining content layouts that have received excellent ratings to continue to provide high-quality information.
- Identify and address suggested points for improvement by respondents in the "good" and "needs improvement" categories, in order to refine and optimize the content of the chapter.



Interpret Q2:

The responses indicate that the overwhelming majority of respondents (96%) find the material in Chapter 2 to be very easy to navigate. This positive feedback reflects a clear structure and accessible language, making it easier to understand the information presented about exacerbated fear and post-traumatic stress. A small percentage (4%)

indicated that the material is partially easy to navigate, suggesting that there are a few sections that could benefit from further clarification to further improve accessibility.

None of the respondents found the chapter difficult to navigate, which confirms that, overall, the content is well-structured and accessible.

Recommendations:

- Continue to use the current structure and style to maintain the ease of navigation appreciated by the majority of respondents.
- Identifying and reviewing sections that have been perceived as partially easy to navigate in order to ensure a reading experience that is as fluent and accessible as possible for all readers.



Interpret Q3:

This positive feedback suggests that the language used is clear, accessible and well adapted to the target audience, facilitating the understanding of concepts related to exacerbated fear and post-traumatic stress. A small percentage (4%) mentioned that the terms and expression are partially easy to understand, indicating that there are certain sections or terms that may need further clarification to improve comprehensibility. None of the respondents found the terms and expression difficult to understand, which confirms that, in general, the language used is appropriate and effective.

Recommendations:

- Continue to use the current language and style of expression, given the majority positive feedback.
- Review and clarify terms and sections that have been perceived as partially understandable to ensure a complete and fluent understanding of the material.



The absence of any negative or indecisive answers shows that the material is perceived as clear and valuable in conveying essential knowledge about PTSD, leaving no room for confusion or doubt.

Recommendations:

- Maintaining current content, given the unanimously positive feedback.
- Applying the same clear and informative approach in the other chapters of the brochure to ensure a consistent level of usefulness and relevance.



Interpret Q2:

The majority of respondents (92%) believe that going through this chapter will be helpful for active and reserve military personnel. This positive feedback indicates that the material is perceived as valuable and relevant to support the understanding and management of exacerbated fear, an important precursor to post-traumatic stress. No respondent indicated that the material would not be helpful, suggesting that there are no significant negative perceptions of the chapter's usefulness. However, 8% of respondents answered "I don't know", which shows that there is a small degree of uncertainty regarding the impact of the chapter. This may reflect either a lack of personal experience with the subject or a need for further clarification.

Recommendations:

- Maintaining and developing current content, taking into account predominantly positive feedback.
- Addressing the uncertainties expressed by respondents who chose the "I don't know" option by adding concrete examples and case studies to illustrate how the chapter can help active and reserve military personnel.

Interpret Q1:

































- The terms and wording were described as very easy to understand, with a small percentage of respondents indicating the need for further clarification for certain sections.
- The material was perceived as well structured and easy to navigate, facilitating the understanding of the topics addressed.

Usefulness

- Respondents unanimously considered the brochure to be useful for understanding post-traumatic stress disorder.

- Most of them considered that going through the material will help both active and reserve military personnel, providing them with relevant and valuable information for managing post-traumatic stress.

Recommendations

Maintaining the positives

- Continue to use design elements that have received mostly positive feedback to maintain the high visual standards and attractiveness of the material.
- Maintaining the structure and style of presenting information, given the very positive feedback on ease of reading and understanding of terms and expression.

Implementing Suggested Improvements

- Evaluating and implementing design review suggestions to make minor adjustments that could improve the visual experience and overall appeal of the material.
- Clarifying sections and terms that have been perceived as partially understandable to ensure complete and fluent comprehensibility.
- Add practical examples and case studies to illustrate the applicability and usefulness of the material, thus reducing the uncertainty expressed by a small part of the respondents.

Ensuring continued relevance and effectiveness

- Continue to apply the same clear and informative approach across all chapters of the brochure to ensure a consistent level of usefulness and relevance.
- Monitoring continuous feedback from users and making necessary adjustments to meet military needs and expectations in an effective and relevant manner.

These findings and recommendations provide a clear direction for improving and refining the booklet, ensuring that it continues to be a valuable and effective tool for educating and supporting military members in managing post-traumatic stress.
